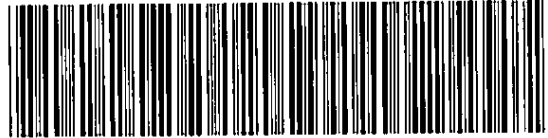

## ARTICLES OF DISSOLUTION OF DAYTONA STATE COLLEGE, INC.

THE UNDERSIGNED duly authorized officer of Daytona State College, Inc., a Florida not for profit corporation (the "Corporation"), hereby makes these Articles of Dissolution for the purpose of dissolving the Corporation in accordance with Chapter 617, Florida Statutes, and states as follows:

### ARTICLE I

The name of the Corporation being dissolved is Daytona State College, Inc., a Florida not for profit corporation. The document number of the corporation is: N04000001889.

### ARTICLE II

The Corporation has no members. The Corporation's dissolution was authorized by resolution of the board of directors at a board meeting held on July 23, 2024, by a majority vote of the directors in office, in accordance with Sections 617.1402(2) and 617.0820, Florida Statutes.

### ARTICLE III

These Articles of Dissolution shall be effective as of the date they are accepted for filing by the appropriate office of the State of Florida, Department of State.

### ARTICLE IV

All known debts, obligations and liabilities of the Corporation have been or will be paid or discharged. The directors of the Corporation have authorized Thomas Lobasso, in his capacity as President of the Corporation to transfer all property and assets of the Corporation (and where applicable, seek regulatory approval to transfer such assets or property) remaining after the payment of its debts and obligations (if any), to The District Board of Trustees of Daytona State College, Florida a public body corporate, for no consideration, as long as such organization is recognized as an exempt organization, as described in Section 501(c)(3), 170(c) or 170(c)(3) of the Code of 1968, as amended, or corresponding sections, if any, of any prior or future Internal Revenue Code, or the Federal, State or local government for exclusive public purpose.

### ARTICLE V

There are no suits pending against the Corporation in any court.
