ARTICLES OF INCORPORATION OF TRAUMA VICTIMS FOUNDATION, INC.

TALLAHASSEE, FLORIGA

The undersigned persons, acting as incorporators of a not-for-profit corporation under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for the corporation:

ARTICLE I NAME

The name of the Corporation is TRAUMA VICTIMS FOUNDATION, INC.

ARTICLE II

The initial principal office and mailing address of the Corporation shall be 100 N. Biscayne Blvd., Suite 2608, Miami, Florida 33132.

ARTICLE III PURPOSES

Section 3.1. The Corporation is organized exclusively as a not-for-profit foundation to offer assistance to victims and survivors of both physical and mental trauma and/or torture who may be eligible for benefits under the Immigration & Nationality Act.

- A. To educate the legal and healthcare professionals, as well as the general public concerning the effects of trauma or torture on individuals and society.
- B. To arrange for psychological evaluation and counseling and limited treatment; to prepare necessary documentation concerning the evaluations for presentation to the court system and to assist in providing expert testimony at court proceedings.
- C. To conduct any and all lawful affairs and business for which corporations may be organized and operated under the Florida Not for Profit Corporation Act as exempt organizations under Section 501(C)(3) of the Code, consistent with the provisions of this Article III, and

Section 3.2. Notwithstanding the foregoing or any other provisions of the Articles or Bylaws of the Corporation:

A. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, any member of the Corporation or the Corporation's directors or officers, or any other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above.

- B. No substantial part of the activities of this Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except to the extent permitted pursuant to an election made under Section 501(h) of the Code, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office; and
- C. The Corporation shall not carry on any activities not permitted to be carried on by an exempt organization under Section 501(C)(3) of the Code or by an organization contributions to which are deductible under Section 170(C)(2) of the Code.

ARTICLE IV TERM OF EXISTENCE

The Corporation shall commence its existence with the filing of the Articles. The Corporation shall exist perpetually, unless dissolved according to law.

ARTICLE V MEMBERSHIP

THE Corporation Board of Directors shall compromise the Membership.

ARTICLE VI NONSTOCK BASIS

THE Corporation is organized on a nonstock basis.

ARTICLE VII INITIAL REGISTERED AGENT AND OFFICE

The street address fo the initial registered office of the Corporation shall be:

The name of the initial registered agent of the Corporation at the above specified address shall be: Jeffrey A. Bernstein, Esq.

ARTICLE VIII DIRECTORS

Section 8.1. The business of this Corporation shall be conducted and managed by a Board of Directors, consisting of a minimum of three (3) Directors. The method of the election of the Directors shall be stated in the Bylaws.

Section 8.2. The officers of this Corporation shall consist of a president, vice-president, secretary and treasurer and such other officers and agents as may be provided for by the Bylaws of the Corporation, who shall be chosen, serve for such term, and have such duties as may be prescribed by such Bylaws.

ARTICLE IX INCORPORATORS

ARTICLE X BYLAWS

The Bylaws of the Corporation are to be adopted by the Officers of the Corporation, and may be amended only by a majority vote of the Board of Directors.

ARTICLE XI AMENDMENTS

These Articles of Incorporation may be amended from time to time by a majority vote of the Board of Directors.

ARTICLE XII DISSOLUTION

On dissolution of the Corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of the Corporation, shall be distributed to another not-for-profit organization with similar purposes within the State of Florida.
