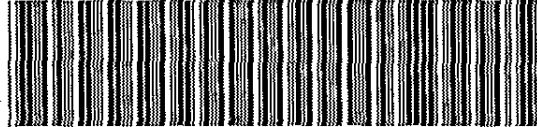

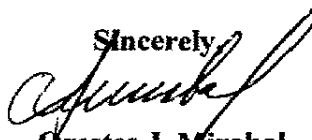

ARTICLE I:

The name of the corporation shall be:

ARTICLE II:

ARTICLE III:

The specific purpose, this corporation is organized is:

- a) To recruit members in Florida as a pilot program to CAIMAN CUBAN AMERICAN INVENTORS MUTUAL ASSOCIATES NETWORK (A Nonprofit Corporation), and optimistically looking forward to setting up chapters across the United States as a unified entity, focus and driven with an integrated force to serve as a support platform.**
- b) To help gifted low income individual inventors, scientist and youth in the United States develop their full intellectual potential.**
- c) To accept corporate, commercial, business or individual donations from our members and sponsors as well as the public. To encourage voluntary services from diverse professions; To the advancement of said beneficiaries for which this corporation is here by constituted. ARTICLE VIII:

Starting February 15, 2004, To February 15, 2008, Orestes J. Mirabal, Founder of the CAIMAN CUBAN AMERICAN INVENTORS MUTUAL ASSOCIATES NETWORK (NONPROFIT CORPORATION). Will hold in trust, the Directorship as Chairman of this Corporation, and would at his discretion appoint executive officers within (90) days to carry on the activities set forth in this corporation; and will provide at least three corporate executives within the time frame of the law to be included in ARTICLE V. After said trust term has expired, having solidify the foundation and having maintained the constituted course of this corporation and having said corporation attained strong roots to stand firm in its incorporated agenda Orestes J. Mirabal would relinquish his directorship and set forth an open election among its corporate members according to our by laws; Hence elect all executive positions according to The Model Nonprofit Corporation Act of the American Bar Association under any amendment incorporated to said act as it applies to The Governing Laws of the State of Florida, to include its Local Government regulatory guidelines in its county and city of residency.

ARTICLE IX:

We here by give notice that this corporation would claim a tax certificate 501 (c3) for tax exemption from the corresponding legal authorities within the legal time frame as set forth by said authorities. As well as to register with the State of Florida Division of Consumer Services as required by law to accept donations within the legal parameters of the law regulating such corporations. Further more here by give notice to said authorities, that in case of a corporate dissolution any and all Corporate Assets will be strictly dedicated and disbursed to a tax exempt purpose.
