Articles of Incorporation of Knights Wrestling Association Inc.

A Florida Not for Profit Corporation

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida Not for Profit Corporation adopts the following articles of incorporation.

Article I - Name

The name of the Not for Profit Corporation shall be Knights Wrestling Association, Inc. (the "Corporation"). Said not for profit corporation is organized exclusively for charitable, educational and scientific purposes including for such purposes the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

EFFECTIVE DATE

Article II - Principal Location

The address of the principal office of the Not for Profit Corporation shall be Monarch High School, 5050 Wiles Road located in the City of Coconut Creek, Broward County, Florida 33073.

Article III - Purpose

This Not for Profit Corporation was specifically created for charitable, educational and scientific purposes, including for such purposes, the making of distributions that qualify under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code for the benefit of the minors of Monarch High School and of Knights Wrestling Association, Inc.

Article IV - Manner of Election of Directors and Officers

The succeeding officers and directors of the not for profit corporation shall be elected in accordance with the terms and conditions set forth in the hylaws.

Article V - Initial Directors and Officers

#### Article VI - Registered Agent

The initial registered agent of the not for profit corporation is Linda S. Zaca. The street address of the initial registered office is 612 NW 47th Terrace, Deerfield Bosch, FL 33442.

#### Article VII - Incorporator

The incorporator of the not for profit corporation is Linda S. Zara, a United States citizen. The street address of the incorporator is 612 NW 47th Terrace, Deerfield Beach, FL

#### Article VIII - Powers, Distributions and Disbursements

The not for profit corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapter 617, Florida Statutes, as amended and supplemented.

The not for profit corporation shall also be authorized to engage in and transact any and all lawful business within that without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 716, Florida Statutes, as amended and supplemented.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private person except that the not for profit corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherence of purposes set forth in sections 501(c)(3) purposes. No substantial part of the activities of the not for profit corporation shall be carrying on of propaganda or otherwise attempting to influence legislation and shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on bahalf of or in opposition to any candidate for public office. Notwithstanding any other provision of the Articles, the not for profit corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this not for profit corporation.

Notwithstanding any provisions contained in these articles, the not for profit corporation is required to distribute its income for each taxable year at the time and in the manner as not to subject the corporation to tax under section 4942 of the Internal Revenue Code. In addition, the corporation shall not during any period, and to the extent it is a private foundation described in section 509 of the Internal Revenue Code, (a) engage in any act of self-dealing; (b) retain any excess business holdings; (c) make any investments in a manner as to subject the corporation to tax under section 4944 of the Internal Revenue Code; or (d) make any taxable expenditure as defined in section 4945(d) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the not for profit corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code.

#### Article IX - Amendments

Amendments to the Not for Profit Articles of Incorporation must be made pursuant to the provisions of Chapter 617, Florida Statutes and Internal Revenue Code section 501 (c)(3) or any corresponding section of any future federal tax code. Amendments must be adopted by the members and must be by majority of the voting members at an official duly noticed meeting.

#### Article X - Dissolution

This not for profit corporation shall be perpetual. Upon the dissolution of the not for profit corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

#### Article XI - Effective Date

The effective date of theses Not for Profit Articles of Incorporation is February 25, 2004.
