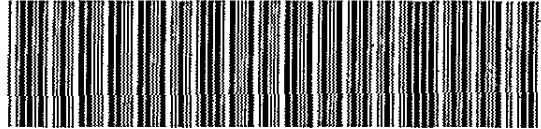

ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of the corporation shall be Fort Lauderdale Schools of Aikido International Inc.

**ARTICLE II**

The principal place of business and mailing address of this corporation shall be 2700 N.W. 56<sup>th</sup> Ave Suite 520 Lauderdale FL 33313. The mailing address shall be P.O. Box 771022 Coral Springs FL 33077-1022.

**ARTICLE III**

This *Voluntary Health Welfare Organization* is formed to provide various kinds of health, welfare and community services for low or no fee to various segments of society. It is tax exempt, organized for the public benefit supported by public contributions and other contributions, operated on a not-for-profit basis.

**ARTICLE IV**

Section 1. The officers of the corporation shall be a president, a vice president, a secretary, and treasurer, who shall be elected annually. Their term of office shall be at the discretion of the Board of Directors.

Section 2. The president shall be the principal executive officer of the corporation to execute the decisions of the Board of Directors. He shall supervise and control the business and affairs of the corporation and preside at meeting of the shareholders and directors.

Section 3. The vice president, secretary, and treasurer shall act under the direction of the president. The vice president shall perform the duties of the president when the president is absent or unable to act. The secretary shall prepare and keep minutes of the meetings of the Board of Directors and shall have general charge of records of the corporation. The treasurer shall have custody of the funds and keep financial records.
