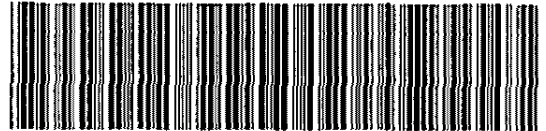


As per my conversation with your department, enclosed please find the required amendments to Help Us Help Others Ministry, Inc. **N04000002087**
