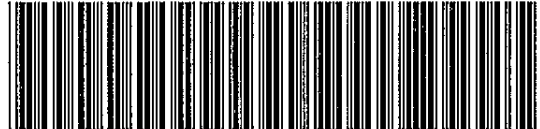

**ARTICLES OF INCORPORATION  
OF  
SHERWOOD FOREST FRONT PORCH, INC.  
(A Florida not-for-profit corporation)**

**ARTICLE I  
NAME**

The name of this corporation shall be "Sherwood Forest Front Porch, Inc." hereinafter referred to as "the Corporation."

**ARTICLE II  
LOCATION**

The principal place of business and mailing address of the Corporation shall be *9619 Spottswood Road East*, Jacksonville, Florida *32208*, or at such other location within the State of Florida as may be hereafter established by the Board of Directors.

**ARTICLE III  
PURPOSE**

This Corporation is organized exclusively for charitable, educational, and scientific purposes, including, but not limited to the promotion of economic growth and development within the community. In effectuating such general purpose the Corporation may on a non-profit basis:

- (a) Acquire by gift of otherwise, and hold, sell, convey, assign, mortgage, and lease any real or personal property necessary or incidental to the accomplishment of the non-profit purposes of the Corporation.
- (b) Borrow money and issue evidence of indebtedness; and secure loans and other indebtedness by mortgages, deeds of trust, pledges, or other liens upon the property of the Corporation.

The Directors will be appointed, at which time periods of the appointments will be set after the First Annual Meeting is held. The number of Director may be increased or diminished from time to time by By-laws adopted by the Board, but shall never be less than one. Initially the Number of Directors shall be Six.

## ARTICLE VI REGISTERED AGENT

## ARTICLE VII INCORPORATOR

## ARTICLE VIII POWERS

The Corporation shall have all the powers of not-for-profit corporations under Chapter 617, Florida Statutes, or successor laws.

**ARTICLE IX**  
**TERM OF EXISTENCE**

The Corporation shall have perpetual existence, unless sooner dissolved in accordance with Florida law.

**ARTICLE X**  
**DISSOLUTION**

Upon the dissolution of the Corporation, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

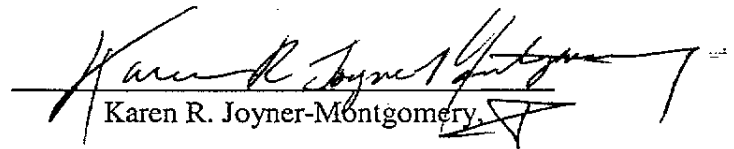
**ARTICLE XI**
