ARTICLES OF INCORPORATION

The undersigned incorporator(s) to these Articles of Incorporation hereby form a corporation pursuant to Florida Statute Chapter 617, the "Corporation Not For Profit Act" under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation shall be: **DELIVERED MINISTRIES, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 362 N.W. Streamside Ct., Lake City, Florida 32055.

**ARTICLE III. EFFECTIVE DATE AND
TERM OF EXISTENCE**

The effective date of this Corporation will be upon the filing of these Articles of Incorporation by the Secretary of State, and the duration of this Corporation shall have perpetual existence.

ARTICLE IV. PURPOSE

This Corporation is organized and shall be operated exclusively for religious, charitable, athletic, and educational purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986. More specifically, this Corporation is organized for the purpose of assembly/meeting, fellowship, worship, singing, preaching, teaching, ministering and/or honoring the Lord Jesus Christ.

ARTICLE V. MANNER OF ELECTION

The manner in which the directors are elected or appointed is set forth in the Bylaws of **DELIVERED MINISTRIES, INC.**; however, if not set forth in the Bylaws, then the manner in which the directors are elected or appointed is: Majority vote of all the initial directors and/or officers listed in Article V of this Article of Incorporation.

ARTICLE VI. POWERS

The powers of this Corporation shall be exercised, its properties controlled, and its affairs conducted by the Board of Directors(Directors) composed of four(4) members initially. The number of Directors may be either increased or decreased from time to time by the Bylaws, but shall never be less than three (3). This corporation is authorized and empowered to do all things necessary to carry on and accomplish the purposes for which it is organized and chartered, subject

only to limitations imposed by the Articles of the Constitution and Bylaws of DELIVERED MINISTRIES, INC., including all authority and power granted by Florida Law.






