

### ARTICLES OF INCORPORATION In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I - NAME**

The name of this corporation shall be: Visual Deixis Incorporated

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 905 Wild Cherry Court, Heathrow, Florida 32746

#### ARTICLE III – PURPOSE

This corporation is organized exclusively for scientific and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section 501(c)(3) exempt organizations. To this end, the corporation shall actively pursue pure and applied research into the diverse ways and means of applying computational science and technology to matters of the human thought and cognitive processes in the areas of mathematics and science at junior and intermediate levels of education. The corporation will undertake to carry out active research with the goal of yielding fundamentally new insights into knowledge representation, knowledge manipulation, knowledge transfer, knowledge capture, semantics, semiotics, pedagogy and the relationships between these areas. To this end, this corporation will pursue pure and applied research in these areas and will continuously make its results and findings available in the form of newsletters, published research and extensible proof of research prototypes to any and all who will take the viable ideas forward and translate them into tools for enhancing the quality of mathematical and scientific education. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

#### ARTICLE IV - Manner of Election

The management and affairs of the corporation shall be at all times under the direction of the Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws. Directors of the corporation have been selected based on their demonstrated abilities in the field of computation and/or education and shall be required and expected to provide continuing guidance to the founding principles. The corporation will make available reasonable compensation for services rendered and authorized expenses incurred on its behalf. No member or Director shall have any right, title, or interest in or to any property of the corporation. No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this

corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.
