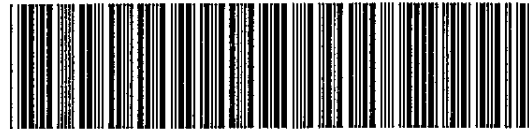

The Undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, **not for profit** in compliance with Chapter 617.0202 et seq, of the Florida Statutes do hereby certify:


First:      The name of said corporation shall be **Anointed Praise Fellowship** & shall operate in conjunction with the **Divine Revelation Ministries**.

Second:    The place in the state where the principal office is to be located is the City of Orlando, Florida.

Third:      The primary purpose for which this corporation is to be established is to: Provide a place of worship for its members and conduct the same according to the rules, regulations, customs, and practices set forth in the **Constitution** of the church; holding & disbursing gifts, bequests, & funds arising from other sources; owning & maintaining suitable real estate & buildings and doing all things necessary or indicant thereof.
