# ARTICLES OF INCORPORATION FOR HERNANDO COUNTY INTERGROUP, INC.

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I - NAME**

The name of the corporation is HERNANDO COUNTY INTERGROUP, INC.

#### **ARTICLE II - ADDRESS**

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501[c][3] of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170[c][2] of the Internal Revenue Code, or corresponding section of any future federal tax code.
