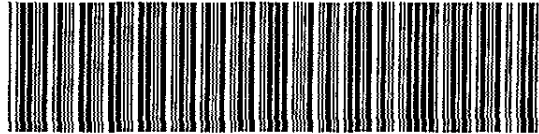

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is **HERNANDO COUNTY INTERGROUP, INC.**

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

THIS CORPORATION EXPRESSLY DISCLAIMS ANY PROFIT MOTIVE OR PURPOSE. The corporation is a not-for-profit corporation under the Laws of the State of Florida.

- A. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, within the meaning of Section 501[c][3], including for such purposes the making of distributions to organizations that qualify as exempt organizations under Section 501[3][c] of the Internal Revenue Code, or corresponding section of any future

federal tax code.

- B. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501[c][3] of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170[c][2] of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV - DURATION

The duration of the corporation is perpetual.

ARTICLE V - NONSTOCK BASIS

The corporation is organized on a nonstock basis. This corporation shall not issue shares of stock.

ARTICLE VI - ELECTION OF DIRECTORS

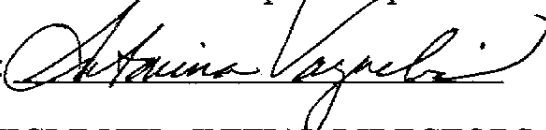
The manner in which directors are elected or appointed is pursuant to the Bylaws of this corporation.

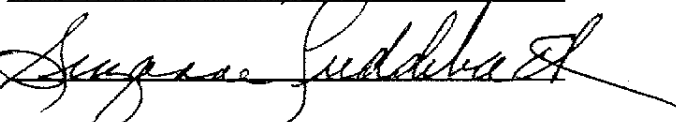

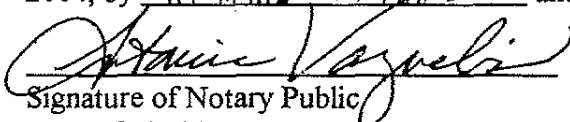

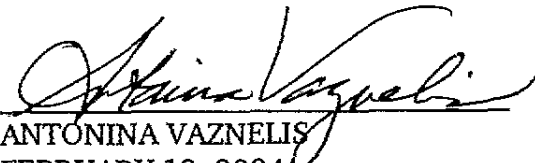
