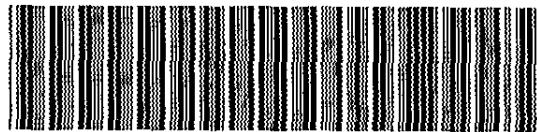

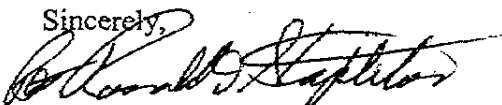

ARTICLES OF INCORPORATION
(In Compliance with Chapter 617, F.S., (Not for Profit))

ARTICLE I - NAME

The name of the corporation shall be: **END TIME EVANGELISTIC MINISTRIES, INC.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: **6105 Lewis Ave. - Gibsonton, FL 33534-4705.**

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is:

- A. **END TIME EVANGELISTIC MINISTRIES, INC.** is a **RELIGIOUS NON-PROFIT CORPORATION** and is not organized for the private gain of any person. It is organized under the Non-profit Religious Corporation Law exclusively for religious purposes.
- B. The specific purposes for which this Corporation is organized are all lawful purpose or purposes within the provisions of the Code, which purposes include, without being limited to, any one or more of the activities enumerated herein but limited to those activities which fall within the meaning of the Internal Revenue Code Section 501 (c)(3), the Florida Non-Profit Religious Corporation Code and other applicable provisions of the Federal and State tax codes regarding tax exempt organization and activities. Without limiting the foregoing, the Corporation is organized to operate as an evangelistic ministry including evangelism through various forms of media, music, training seminars, biblical counseling, minister to the homeless, feed the poor, and other programs to prepare Christian men and women to effectively represent Jesus Christ in winning the world to Jesus, and in reaching others to become soul winners for Jesus, and for other lawful purposes allowed by the Florida Non-Profit Religious Corporation laws.
- C. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt under Federal Income Tax under Section 501 (c) 3 of the Internal Revenue Code of 1986 or any future code thereof.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected or appointed:

END TIME EVANGELISTIC MINISTRIES, INC. will hold an annual meeting, each year at such time and place as the directors may determine. At such meeting, the Board shall be elected by majority vote for the coming year.
