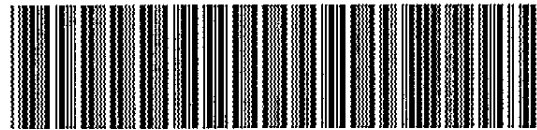

ARTICLES OF INCORPORATION

OF

ASSISTANCE DOGS TRAINING AND EDUCATION CENTER, INC.

A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is:

ASSISTANCE DOGS TRAINING AND EDUCATION CENTER, INC.

Article 2 Duration. The duration of the Corporation is perpetual.

Article 3. Purposes. The purpose of the corporations is as follows:

- A. To educate the general public and particularly the agricultural and medical communities about assistance dogs and therapy dogs. In addition, the ASSISTANCE DOGS TRAINING AND EDUCATION CENTER, INC. will train and place these animals in homes when possible and where needed regardless of ability to pay.
- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4 Members. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
