

Articles of Incorporation Of Timucua Arts Foundation, Incorporated A Nonprofit Corporation



Articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

Article 1: The name of the corporation shall be:

Timucua Arts Foundation, Incorporated

Article 2: The Place in this state where the principle office of the Timucua Arts Foundation, Incorporated (TAFI) is to be initially located is the City of Orlando, Orange County. 11113 Finchley Place Orlando, FL 32837

Article 3: TAFI is organized exclusively for charitable, educational, and artistic purposes to support and promote the performing, visual, and literary Arts in Central Florida. The primary purpose of TAFI will be to organize and sponsor free musical performances, to provide a free venue for visual artists to display their works, and for writers to read or display their literary works.

Article 4: TAFI shall have five (5) directors. The initial Directors' names and addresses are:

The current Board of Directors shall elect the Board of Directors for the following year as prescribed in the Bylaws.

Article 5: No part of the net income of Timucua Arts Foundation, Incorporated shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that Timucua Arts Foundation, Incorporated shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of Timucua Arts Foundation, Incorporated shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and Timucua Arts Foundation, Incorporated shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, Timucua Arts Foundation, Incorporated shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of Timucua Arts Foundation, Incorporated.

Article 6: Upon the dissolution of Timucua Arts Foundation, Incorporated, assets shall be distributed to the University of Central Florida public radio station, WUCF, for the broadcasting of live Jazz music in Central Florida. A Court of Competent Jurisdiction of Orange County, shall dispose of any such assets not so disposed exclusively for such purposes or to such organizations as said Court shall determine, which are operated exclusively for such purposes.
