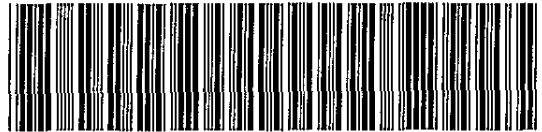

ARTICLES OF INCORPORATION
OF

a Florida Corporation

The undersigned, acting as incorporator of MOMSWEB, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME
