Of

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be Trail Riders for Intervention & Prevention, Inc.

ARTICLE II: ADDRESS

The principal place of business and mailing address of this corporation shall be 9541 Old Plank Road, Tallahassee, Florida 32305.

ARTICLE III: PURPOSES

PURPOSE #I:

The specific purpose for which this corporation has been organized is to provide a program that will teach troubled or disadvantaged youth, to channel their energies in a positive direction. This program will provide equine education and vocational training opportunities for youth hoping to pursue careers in animal science. This program will guide the youth in developing leadership qualities, learn positive goal setting techniques and to become good role models.

PURPOSE #II:

The secondary purpose for which this corporation has been organized is to provide food and shelter for abused or neglected horses. By integrating abused or neglected horses into the program, participants will be able to form a bond with the animals creating a mutual trust. By nurturing another living being, participants will learn life skills as well as nurturing skills, which will help them to develop self-esteem, self-confidence and self-discipline. An animal-child relationship will help to create a constructive foundation for communicative relationships with other people in the process.

Trail Riders for Intervention & Prevention, Inc. is committed to bringing troubled or disadvantaged youth and abused or neglected horses together to form mutually beneficial relationships.




