Article I Name:

The name of the corporation shall be:

Article III Purpose:

The purpose for which the corporation is organized is:

For educational, charitable, and community unity, to aid the poor disadvantaged individuals, to perform community services, feed the poor, housing, provide jobs etc.

This organization is organized exclusively for charitable, educational or scientific purpose within the meaning of section 501 (c) (3) of the Internal Revenue Code.

No part of the net earning of the organization shall insure to the benefit of or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of these purposes.

No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or

intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities not permitted to be carried on

(a) By an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed exclusively for such purposes or to such organization or organized and operated exclusively for 501 (c) (3) purposes.

Article IV Manner of Election:

The manner in which the directors are elected or appointed:

There shall be 2/3 votes of existing Board of Directors.




