- ONE: The name and address of this principal corporation is **THE SANCTUARY TECHNO-CENTER, Inc.**, 606 N.W. 183rd Street, Miami Gardens, Fl 33169, our mailing address is 17120 N.W. 42nd Ct, Miami, Florida 33055-4413, in Miami-Dade County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit *Public Benefit Corporation Law for charitable and educational purposes to aid* the poor and disadvantaged individuals and families towards a life of self-sufficiency. The program will consist of, but not limited to: Job Training, Job Placement, Land Acquisition, Housing, Employment, Computer Technology Training, Literacy, Counseling, Temporary Shelter, Teen Pregnancy, Mentoring Programs, Domestic Violence, Gang Involvement, Substance Abuse Awareness and Prevention, Tutoring, Juvenile Delinquency Prevention, Conflict Resolution, AIDS, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, having no stock, and shall have no members.
- FOUR: The address of the Registered office is: 17120 Northwest 42nd Ct, Miami, Florida, 33055-4413, and the name and address of the registered agent of the corporation shall be:

- FIVE:
- a. This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
 - b. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

SIX: The Directors are elected in accordance with the Bylaws. The name and Address of the persons appointed to act as the initial Directors of this corporation are:



SEVEN: The property of this corporation is irrevocable dedicated to *Charitable and Educational purposes and no part of the net income or assets or the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.* The Corporation shall be authorized and empowered to pay reasonable compensation to those people for services rendered, and to make payment and distributions in furtherance of its stated purposes.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Educational and Charitable purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or *shall be distributed to the federal government, or to a state or local government for a public purpose.* Any such asset not disposed of shall be disposed of by the Court or Common Pleas of the county in which the principal office of the organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
