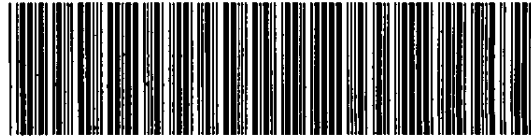

ARTICLE III Said organization is organized exclusively for charitable, religious education, and scientific purposes, including, for such purposes as the making of distributions to organizations that qualify as exempt organization under section 501(c)(3) of the IRS, or corresponding section of any future federal tax code. The primarily purpose for which this corporation is formed is to glorify God by conducting self-supporting, independent, local Pentecostal church in accordance with the Word of God RVA 1960 - seeking to win the lost to Christ, assembling for prayer, spiritual fellowship and worship; preaching and teaching the whole counsel of God; administering the ordinances as baptize, administer the Lord's supper washing of the saint's feet, and solemnize the rites of matrimony a legal marriage between a man and woman with the sex assigned to them at birth; maintaining a testimony of godliness and good works in the community; carrying on a worldwide missionary program; standing for the biblical faith licensing and ordaining qualified men of like faith to the gospel ministry; exercising biblical discipline; instituting, operating, and maintaining associated ministry for evangelism as founding and organizing churches in this state and out of the country, education as day care, school seminars and university; discipleship spiritual growth and any other ministry to church deems necessary, shall receive a offerings, contributions and donations for the accomplishments of these purposes.

No substantial part of activities of the organization shall be to carry on off propaganda, or otherwise attempting to influence legislation, and the invention organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, of (b) any organization, contribution to which our deductible under section 170 (c) (2) of the Internal Revenue Code, or a corresponding section of any future federal tax code.

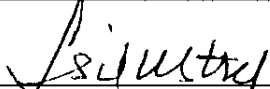
