AMENDMENTS ADOPTED:

Article III PURPOSE removed. Amended Article III now reads:

ARTICLE III PURPOSE.

This corporation is organized exclusively for educational and social purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code of 1986. To this end, the corporation shall sponsor and promote social events which educate and inform attendees about the safe enjoyment of wine and wine appreciation.

The first sentence of <u>Article IV SELECTION OF DIRECTORS</u>, is hereby amended to read:

The corporation shall have no voting members, other than the members of the Board of Directors, and shall issue no stock.

<u>Article VIII LIMITATIONS</u> removed. Amended Article VIII now reads:

ARTICLE VIII LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of the corporation:

1. No part of the net earnings of the corporation shall inure to any member of the corporation, nor to any Director or officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation.

2. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(7) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

Adoption of Amendments:

The date of adoption of the above amendments was August, 26 2005.

There are no members entitled to vote on these amendments. The amendments were adopted by the board of directors.
