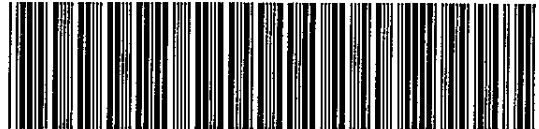

**ARTICLE III PURPOSE**

The purpose of L'Chaim Foundation, Incorporated, is to provide short-term emergency financial assistance for cancer patients in need. This assistance includes payments or vouchers for living expenses (including utilities, rent or mortgage payments), transportation, medical deductibles and counseling/support (based on referrals). This assistance is only for *single, unemployed cancer patients*, defined as "a diagnosed cancer patient undergoing treatment, living with no spouse or dependent children or source of income."

**ARTICLE IV MANNER OF ELECTION**

The President and Vice-President (co-founders) are appointed initial directors and officers by mutual consent. The Treasurer and Secretary are appointed by mutual consent of the President and Vice-President. Future board members, Directors and officers will be appointed by mutual consent between the President and the Vice-President.
