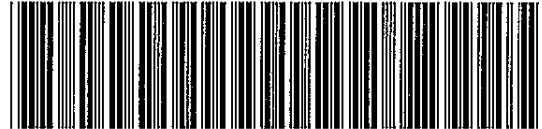

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: DAYTONA BEACH HOUSING DEVELOPERS, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 118 Cedar Street, Daytona Beach, FL 32114.

ARTICLE III PURPOSE
