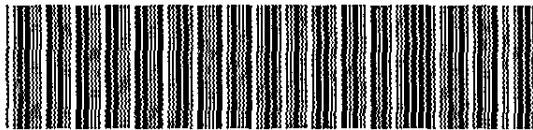

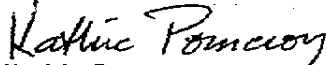

ARTICLE I NAME

The name of the corporation shall be: MedievalFest Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose of MedievalFest Inc. is to provide venues for education, information, demonstrations and to allow members of the public to experience the lifestyle, arts, crafts, skills for daily living activities and foodways of our European ancestors during the Medieval and Renaissance periods of history.

ARTICLE IV MANNER OF ELECTION

1. The Board of Directors shall be elected by consensus from among interested parties involved with or wishing to be involved with the purpose and activities of MedievalFest Inc.
2. The Board of Directors shall consist of a minimum of three and a maximum of five Directors.
3. The Directors shall serve one year terms.
4. The President of the Board may replace Directors by appointment during any unexpired vacant term.
5. A quorum shall consist of two Directors if one is the President, and three if the President is not present.

ARTICLE V INITIAL DIRECTORS AND/OR OFFICERS

1. **OFFICERS AND STAFF**
 - a. The President of the Board shall be elected by acclamation of the other Directors present at the Annual Meeting. The President shall serve as the official spokesperson of the organization. The President shall be responsible for general activities and for delegation and supervision of tasks to the Executive Director.
 - b. The Secretary/Treasurer of the Board shall be responsible for the correspondence, taking the minutes of the Annual Meeting and any other official meetings of the Board, and maintaining the official records of the organization. The Secretary/Treasurer of the Board shall be responsible for oversight of the fiscal duties and responsibilities of

the organization and shall perform or arrange for an annual audit of the organization's accounts.

- c. The Board of Directors may hire an Executive Director. The Executive Director shall, at the direction of the Board, be responsible to the Board, organize and operate all activities of the organization, provide accounting reports, pay lawful debts, receive and account for donations and fees, hire and supervise staff necessary to facilitate activities and events of the organization, and provide such information as required by the Board both verbally at official meetings and in written form to be kept with the official records of the organization.

2. **MEETINGS**

- a. The Annual Meeting shall be held in February.
- b. Official meetings of the Board of Directors may be called by the President or by two Directors at such times as necessary to carry out the business of the organization.
- c. Meetings may be held in person, by conference call, or on the internet in a private chat room.
