Article 1. Name. The name of the corporation is:

Atlantis Playhouse Foundation, Inc.

Article 2. Duration. The duration of the corporation is perpetual.

Article 3. Purposes. The purpose of the corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to promote local arts to the area for theatrical entertainment and to increase public awareness in regard to local arts.
- B. To exercise all rights and powers conferred by laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earning of the corporation shall inure to the benefit of or be distributed to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Directors. The corporation shall have Directors who shall be elected or appointed as provided for in the bylaws.

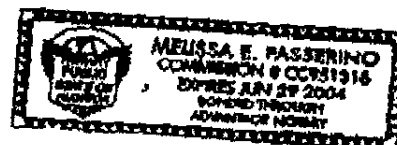
