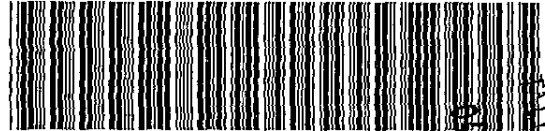

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Corporation shall be:
CPM Outreach, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be:
7637 N. 56th Street
Tampa, FL 33617

ARTICLE III PURPOSE

The purpose for which the Corporation is organized is:

Complete Praise Outreach Incorporated will assemble bag lunches bi-weekly; that feed homeless and hungry citizens in Hillsborough County. As part of the ministry we produce a weekly radio broadcast that markets the outreach ministry and increases the awareness of our listeners to the plight of the homeless and hungry in our community. In addition the outreach program will provide workshops on healthcare, employment, and housing.

- A. This Corporation is an outreach Corporation and is not organized for the private gain of any person. This Corporation is organized and operated exclusively for charitable purposes within the meaning of §501(c)(3) of the Internal Revenue Code.
- B. Notwithstanding any other provision of these articles, the Corporation is organized exclusively for one or more of the following purposes: religious, charitable, public safety, literary, or educational purposes. This Corporation shall not carry on any activities not permitted to be carried on by a Corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code.
- C. The property of this corporation is irrevocably dedicated to religious and charitable purposes meeting the requirements for exemption provided by §501(c)(3) of the Code
- D. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization and organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

A Board of Directors who shall be selected in the manner provided in the Bylaws shall govern the Corporation. The number of persons constituting the entire Board of Directors shall be a minimum of three and a maximum of twenty-five. The Board of Directors shall elect the officers at its first meeting. If a vacancy occurs in any office, the Board of Directors shall fill it.
