ARTICLES OF INCORPORATION OF Mothers On The Move, Inc.

The purchase, receive, take, acquire, hold, sell, convey or otherwise dispose of property whether it be real, personal or mixed; to receive property by devise or bequest, subject to the laws regulating the transfer of property by will, and to otherwise require and hold property, real or personal, including shares of stocks, bonds, and securities of other corporations.

ARTICLE IV TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE V LIMITATION OF LIABILITY

Each director, officer, in consideration for his or her services, shall, in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expenses incurred by him in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against him by reason of his being or having been a director, stockholder or officer of the corporation or of any subsidiary of the corporation, whether or not wholly owned, to the maximum extent permitted by law. The foregoing right of indemnification shall be inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.
