ARTICLES OF INCORPORATION

ARTICLE I - Name

The name of the organization shall be: National Association of Conservative People Inc.

ARTICLE II - Principal Office

The principal place of business shall be: 7883 Turnstone Cir West, Jacksonville, FL 32256; and mailing address of this corporation shall be: P.O. Box 551401, Jacksonville, FL 32255

ARTICLE III - Purpose

Section 1. The purpose of this organization is to act as a voice for its membership; to promote conservative values and ideas which can serve as a shield for the family unit; to educate young adults conservatives principles; to work in preserving the life of the unborn by working with families, adoption agencies and other child welfare agencies; review current social, moral, media and political issues and the impact on families, develop methods to and/or take action on these issues.

Section 2. This organization's objective and purpose being solely of a charitable and educational character and not for pecuniary gain or profit to its members. No part of the income or assets of this organization shall inure to the benefit of any private individual or member. This shall not prohibit payment to individuals for services rendered or assets purchased. It will receive, invest, and disburse finds, and hold property for the purposes of the organization.

ARTICLE IV - Manner of Election

The Board of Directors will consist of no more than 7 members. The Board of Directors itself will have the authority to increase or decrease its number by appropriately amending these by-laws in accordance with Roberts Rules of Order. Board members including President and Vice President, Treasure, Secretary and three board members are to be nominated by a majority vote of the current board in April's meeting (in an odd ending year) and confirmed in like manner every two years.

ARTICLE V - Initial Directors/Officers

This corporation shall initially have three directors. The number of directors may be increased or decreased from time to time but shall never be fewer than one nor more than seven. The name, street address and title of the members(s) of the first Board of Directors of the corporation are:
