ARTICLES OF INCORPORATION

(A Florida Nonprofit Corporation)

The undersigned, being of legal age and competent to contract, acting as incorporator of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

- (1) The name of the corporation is Volusia County Christian Academy, Inc.
- (2) This corporation is a Non-Profit Corporation.
- (3) The period of duration of the corporation is perpetual.
- (4) The name, street address, and mailing of the Registered Agent and Registered Office in Florida is
