ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The Name of the corporation shall be: VERAY-WHITE, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 6001-21 Argyle Forest Blvd. Ste. 207 Jacksonville, Fl 32244

ARTICLE III PURPOSE

The purpose for which this organization is organized:

This organization is organized for charitable and educational purposes- To educate youth, adults, and families on the necessity, benefits, and importance of being a financially responsible adult, how it applies to one's ability to be creditworthy, and how it in fact relates to one's ability to live comfortably and make it in today's society. This corporation is also organized for the purpose of assisting middle to low income families with limited resources in need of financial assistance for down payments toward the purchase of a new home or to pay off minor debts as it relates to one's ability to become financially responsible and credit worthy. This corporation is also being formed to provide these services free of charge to the public, and to conduct any and other lawful business as deemed necessary for the advancement of the purpose of this organization.

In furtherance thereof, for and on behalf of VERAY-WHITE, INC.:

- 1. To purchase, rent, or otherwise acquire facilities, remodel, or rehabilitate facilities to be used for the educational and charitable purposes herein specified, and to purchase or acquire equipment incidental or necessary for use in such facilities; and
- 2. To provide and finance such professional staff and other staff as may be necessary to further any or all of the above purposes; and
- 3. To provide financial education by way of free seminars/sessions to graduating seniors at various high schools and college freshman/ juniors upon their entry into the real world and society as an opportunity to give them the best start financially, particularly for those who are not educated in the home. Free classes will also be given to those families in need of financial education who have been classified as challenged in the area of finance and credit to teach them how to be financially responsible adults as well.
- 4. To adopt bylaws for the administration of the corporation, and to amend the same from time to time in the manner provided therein; provided, no bylaw or amendment thereto may be contrary to or inconsistent with the purposes of the corporation as herein set forth, nor with any provisions of these Articles of Incorporation.
