ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Innovative Partners Coalition, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

1090 Cook Rd, Lamont, Florida 32336

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

IPC, Inc. is a faith-based organization developed to serve the underserved residents of Jefferson County Florida through the following:

1. Assist residents in developing successful entrepreneurial and other business enterprises;
2. Promote development and retention of industries;
3. Expand and facilitate opportunities for low-cost housing;
4. Increase literacy and attainment of higher education;
5. Decrease instances of hunger malnutrition;
6. Promote opportunities for clean air and water; and
7. Decrease death rates due to disease that impact minorities.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

All officers ^{Directors} shall be elected by majority of current officers in the Fall planning meeting on or before October 1st of each year. The current CEO/president will preside over the elections. Potential officers can nominate themselves, or can be nominated by other officers. Nominees may make brief speeches before the votes are cast. Votes will be cast by secret ballot. The president will cast a vote only in the case of a tie. If the election is close, the president may choose to have a run-off election between the leading candidates. Officers can only serve a term of 3 consecutive years in the same position. Upon the unexpected resignation or death of an Officer replacement will occur in the manner described above, except appointment may occur in any month and appointee can only serve for the term of the original office holder.

ARTICLE VI SUPPLEMENTAL ARTICLES

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article Third thereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code; or Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
