ARTICLES OF INCORPORATION

Temple of Triumph, Inc.

Chapter of the Vintage Triumph Register

The undersigned a majority who are citizens of the United States, desire to file Articles of Incorporation for a Non-Profit Corporation. The undersigned adopt the following Articles of Incorporation for such Corporation:

FIRST. The name of the Corporation is Temple of Triumph, Inc.

SECOND. The place in this state where the principle office of the Corporation and the mailing address is 1114 Old Bumpy Road, Tallahassee, Florida 32317.

THIRD. The period of the Corporation's duration is perpetual.

FOURTH. The primary purpose of this Corporation is to promote an interest in owning and operating Triumph sports cars, as well as other British cars in the community. This includes participation in and conduct of events, education, and cooperation with similar groups in the United States and foreign countries and, thereby, to further in some way the common good and general welfare of the people of the community.

FIFTH. The Corporation shall have all powers prescribed by law and all powers necessary and incidental to the fulfillment of its purposes.

SIXTH. The internal affairs of the Corporation shall be regulated by the By-Laws of the Corporation.

SEVENTH. This Corporation shall have no capital stock, is not organized for pecuniary gain, profit or trade, and no part of its net earnings shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article FOURTH thereof.

EIGHTH. Upon the dissolution of the Corporation, the Board of Directors, ^{who are elected} shall, after paying or making provision for the payment of all liabilities of the corporation, dispose of all the assets of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization organized and operated exclusively for charitable, educational, or scientific purposes or to foster national and international Triumph automobile events, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the State of Florida in which its principal office is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

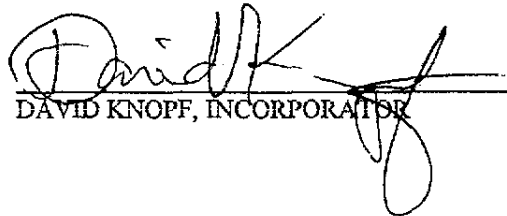

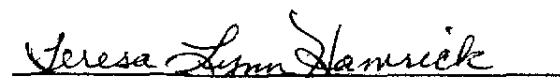
