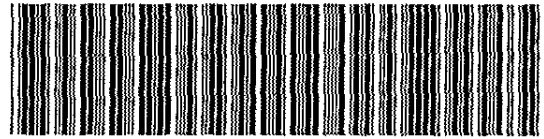

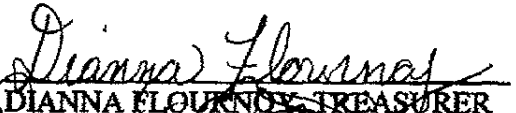

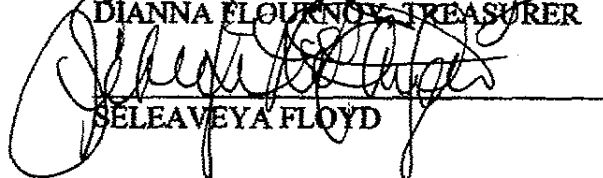
ARTICLE IX

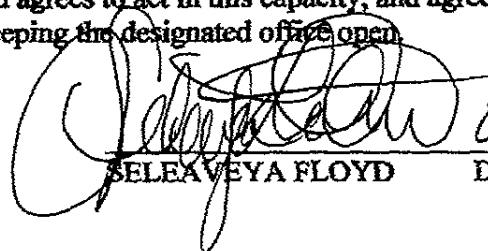
