ARTICLE I

NAME

The name of this ministry for now and hereafter is Joseph's StoreHouse,Inc.

ARTICLE II

The term of this ministry shall be that of perpetual.

ARTICLE III

PURPOSES

The general purposes of this corporation, Joseph's StoreHouse, Inc. shall be as follows:

- (a) For the establishing, managing and funding of Humanitarian Projects such as; Disaster Relief, Feeding The Needy, Caring For Those Designated As Homeless, Caring for The Disenfranchised, and The Support Of Church Related and Religious Organizations this Ministry Deems Appropriate, Teaching and Promoting The Gospel Of Christ To All Nations.
- (b) To participate and Aid organizations involved in Humanitarian, Christian Outreach and Evangelism.
- (c) This ministry shall be totally charitable.
- (d) To acquire by conveyance or inheritance whether by gift or purchase real property, personal property and mixed real and personal property, to be received and or held in trust for the use of this ministry and it's purposes.
- (d) To improve, invest, sell, lease, assign, mortgage or otherwise encumber any such property, when such action is deemed in the best interest of this ministry and it's aforesaid purposes.
- (e) To engage in evangelistic campaigns for the purpose of teaching the gospel to all peoples without charge or obligation.
- (f) To engage in and operate archaeological and historical expeditions and digs and to recover, display, preserve, such finding for historic and religious posterity.
- (g) To solicit and receive funds for each project or campaign as stated in the aforesaid purposes of this ministry.

ARTICLE IV

POWERS

- (a) To accomplish the forgoing purposes, the Ministry shall have powers permitted by it's Board as well as all legal capacity given by law as an independent entity- to operate.
- (b) This ministry is specifically precluded from engaging in any prohibited activities, that would deviate from it's general purposes and laws governing not for profit organizations.

AMENDMENTS TO ARTICLES OF OPERATION

Upon proper notification and decision of and by the Board Of Directors, amendments to these Articles Of Operation may be made to the benefit of the Ministry.

ARTICLE VII

BYLAWS

The board of directors/ ministers shall provide By-Laws for the conduct of it's business and the carrying out of its purposes as they may deem necessary from time to time.

ARTICLE VIII

BUSINESS

- (a) The business affairs of this Ministry shall be managed by three (3) Directors who are also the Trustees, Elders and Pastors of this Ministry.
- (b) The Directors/Trustees shall be duly appointed by the Incorporating Directors/Trustees in Article XI. Thereafter, they shall be elected by a 2/3 vote by the governing Directors/Trustees.

ARTICLE IX

LIMITATIONS AND DISSOLUTIONS

- a.) Joseph's Storehouse, Inc. is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes the making of distributions that qualify as exempt organizations under section 501c3 of the Internal Revenue Code of 1954 (or for the corresponding provision of any future U.S. Internal Revenue Law).
- b.) Notwithstanding, any other provision of these articles, this corporation will not carry on any other activities not permitted to be engaged in by:
 - a corporation exempted from Federal Income Tax under sections 501c3 of the Internal Revenue Code of 1954 or the corresponding provision of any future U.S. Internal Revenue Law, or;
 - 2.) a corporation, contributions to which are deductible under section 170c2 of the Internal Revenue Code of 1954 or any other corresponding provision of any future U.S. Internal Revenue Law.
 - 3.)In the event of dissolution of Joseph's Storehouse, Inc., the residual assets of this corporation will be turned over to a duly authorized Not-For-Profit Organization of the choice of the Board Of Directors/ Trustees, one that falls within the guidelines of the sections 501c3 and 170c2 of the Internal revenue Code of 1954 or the corresponding sections of any prior or future law.

ARTICLE X

ADDRESS OF THE MINISTRY
