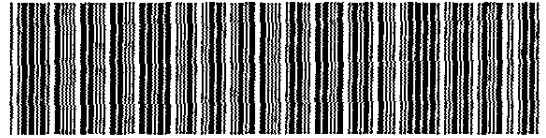



**ARTICLES OF INCORPORATION OF**

**FLORIDALE MOBILE HOME COLONY HOMEOWNER'S ASSOCIATION, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, and under the provisions of Chapter 723, Florida Statutes, including Sections 723.075-723.079 and the rights to acquire the mobile home park under 723.071, hereby adopt(s) the following Articles of Incorporation.

**ARTICLE I NAME**

The name of the corporation shall be:

**FLORIDALE MOBILE HOME COLONY HOMEOWNER'S ASSOCIATION, INC.**

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

1538 S.W. 29<sup>th</sup> Street, Fort Lauderdale, Florida 33315

**ARTICLE III PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is (are)

The purpose for which the Corporation is organized and incorporated to provide an entity to represent the general interest of the mobile home owners who reside in the mobile home park known as FLORIDALE MOBILE HOME COLONY and to have all the rights provided to homeowner's association incorporated under the provisions of Chapter 723, including Sections 723.077, 723.078 and 723.079.

**ARTICLE IV POWERS**

(1) The corporation shall have all the powers of corporations not-for-profit under the laws of the State of Florida, including those under Chapter 723, Florida Statutes.

(2) This corporation has the power to negotiate for, acquire, and operate the mobile home park on behalf of the mobile home owners.

(3) This corporation has the power to convert the mobile home park acquired to a condominium, a cooperative, or a subdivision form of ownership or any other type of ownership.

(4) Upon the acquisition of the property, for the association, by the action of its board of directors, shall be the entity that creates a condominium, cooperation, or subdivision or offers condominium, cooperative, or subdivision units for sale or lease in the ordinary course of business or, if the homeowners choose a different form of ownership, the entity that owns the record interest in the property and that is responsible for the operation of property.

#### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors consisting of not less than five (5) directors and as may be provided by the by-laws. Directors shall be elected at the annual meeting of the members in the manner set forth in the by-laws. Directors may be removed in the manner set forth in the by-laws. The initial Board of Directors shall manage the business of the Corporation until the first annual meeting, as set forth in the by-laws.


