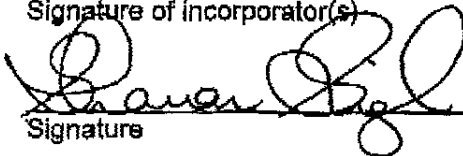
#### ARTICLE IX- Dissolution
