**ARTICLES OF INCORPORATION
OF
WESTLAKE VILLAGE SWIM TEAM, INC.**

The undersigned incorporator desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the State of Florida Not-For-Profit Corporation Laws, execute the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation is Westlake Village Swim Team, Inc.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of the corporation shall be: 2570 Coral Landings Boulevard, Suite 201, Palm Harbor, Florida 34684. The corporation reserves the privilege of having branch or other offices at places within or without the State of Florida.

ARTICLE III - PURPOSES

The purposes for which the Corporation is formed are:

- (a) To establish a youth swim team.
- (b) To do and perform such acts as may be necessary, advisable, proper or incidental in the realization of the objects and purposes of this organization;
- (c) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Corporation as set forth in the Bylaws; and
- (d) To have and exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

ARTICLE IV - MANNER OF ELECTION

The manner of election of the Directors of the corporation shall be as set forth in the Bylaws.

ARTICLE V - DIRECTORS

This corporation shall have four (4) directors initially. The affairs of the corporation will be managed by the Directors as provided by the Bylaws of this corporation. The number of directors may be increased from time to time in accordance with the Bylaws, provided that the number of directors shall not be less than three persons at any time, in accordance with the statutes.

ARTICLE VI - DESIGNATION OF INITIAL REGISTERED AGENT

The name of the initial registered agent of the corporation is Bret T. Jardine. The street address of the initial registered office of the registered agent for service of process shall be 2570 Coral Landings Boulevard, Suite 201, Palm Harbor, FL 34684.

The date of incorporation for the corporation listed above shall be the date of filing of these Articles of Incorporation.

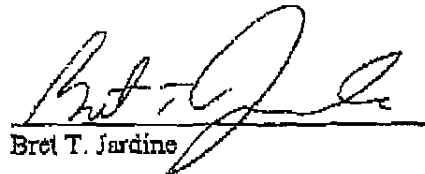
