**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for purposes of forming a corporation not-for-profit under Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be CARIBBEAN RIVER FESTIVAL ASSOCIATION, INC. ("Corporation").

ARTICLE II

ARTICLE III

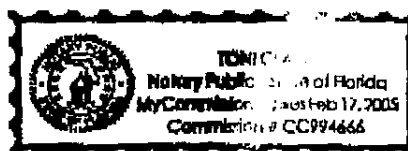
