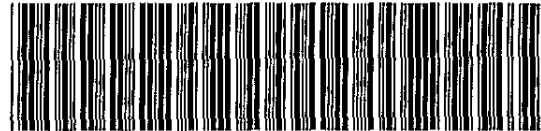

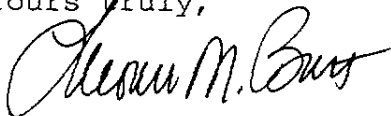

**ARTICLES OF INCORPORATION**

**ARTICLE I. CORPORATE NAME.**

The name of this corporation is **THE GESTALT CENTER OF GAINESVILLE, INC.**

**ARTICLE II. ENABLING LAW**

This is a non-profit corporation organized pursuant to the Florida Corporations Not-for-Profit Law set forth in Chapter 617 of the Florida Statutes.

**ARTICLE III. GENERAL AND SPECIFIC PURPOSES**

(a) The specific and primary purposes for which this corporation is formed are to operate for the advancement of education and for other charitable purposes, by the distribution of its funds for such purposes, and particularly for the growth and training experience with a Gestalt Therapy base.

(b) The general purposes for which this corporation is formed are to operate exclusively for such educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under the Code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.

**ARTICLE IV. TERM OF EXISTENCE.**

This Corporation shall have perpetual existence.

#### **ARTICLE V. INCORPORATORS**

#### **ARTICLE VI. MEMBERSHIP.**

The authorized number, qualifications, and manner of admission of members of this corporation, the difference classes of membership, if any, the property, voting and other rights and privileges of members, the liability of members for dues or assessments and the method of collection thereof, and the termination and transfer of membership shall be as set forth in the By-Laws of this Corporation.

#### **ARTICLE VII. MANAGEMENT OF CORPORATE AFFAIRS**

(a) BOARD OF DIRECTORS. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of not less than three (3) directors. The number of directors herein provided for may be changed by a by-law duly adopted by the members entitled to vote.

This corporation shall be dissolved and its affairs resolved by a two-thirds vote of the corporation's voting members.

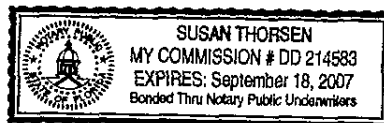
