Pursuant to the provisions of Florida Statutes Section 617.1006, LOVE, TRUTH & DELIVERANCE OUTREACH MINISTRY, INC., a Florida Not-For-Profit Corporation, has adopted the following amendment(s) to its Articles of Incorporation at a Meeting of the Membership which was held on December 6, 2006, having been duly noticed to all Members.

A sufficient number of Members having appeared at said meeting to establish a legal quorum, in accordance with the Corporation's Articles of Incorporation and Bylaws, the proposed Amendments to the Articles of Incorporation were presented to the Members by Senior Pastor Doles (Senior Pastor Hutchinson having failed to appear after being duly noticed).

Thereafter, discussion was held on the proposed Amendments and a vote of the Members was held, at which time a majority of the Members voted to approve the proposed Amendments to the Articles of Incorporation and Bylaws, as follows:

- 1. <u>AMENDMENT TO ARTICLES OF INCORPORATION</u>: At a properly called meeting of the Membership, at which a sufficient number of Members were present to establish a quorum, a Resolution was duly presented, discussed, voted upon and passed by a majority of the Members changing the name of the Corporation to *DIVINE TRUTH & DELIVERANCE MINISTRY, INC.*
- 2. <u>AMENDMENT TO BYLAWS</u>: At a properly called meeting of the Membership, at which a sufficient number of Members were present to establish a quorum, a Resolution was duly presented, discussed, voted upon and passed by a majority of the Members and, thus, the Corporation's Bylaws are amended in the following particulars:

- a. Change from two Senior Pastors to one Senior Pastor, who shall act at the President of the Corporation and Chairperson of its Board of Directors.
- b. Election of the Board of Directors within thirty (30) days of incorporation and annually thereafter during the month of January each year.
- c. Term limits adopted on Board members, whereby Board members are restricted to serving three (3) years, with the exception of the Senior Pastor who shall serve on the Board until removed by a 2/3rds majority of the Church's membership.
- d. Expansion of church to additional locations shall require approval by a 2/3rds majority of the Church's membership.
- e. Contracts or other obligations of the Corporation that exceed \$10,000 or one year in duration or time to perform shall require approval by a 2/3rds majority of the Membership of the Corporation present at a duly called meeting.
- f. Appointment of new Registered Agent: The Registered Agent of the Corporation, as of January 1, 2007, shall be DIANE L. PAULL, ESQ., 3500 3rd Street South, Jacksonville Beach, Florida, 32250.
- 3. <u>CERTIFICATION BY CORPORATE SECRETARY</u>: THE ABOVE RESOLUTIONS ARE HEREBY CERTIFIED by the Secretary of the Corporation having been duly presented and passed by a majority of the Members at a properly noticed and called meeting of the Members held on December 6, 2006.
