ARTICLES OF INCORPORATION

OF

FLORIDA WOMEN'S HOCKEY LEAGUE, INC.

These Articles of Incorporation are signed and acknowledged by the incorporator for the purpose of forming a not-for-profit corporation under the provision of Chapter 617 of the Florida Statutes known as the Florida Not For Profit Corporation Act, as follows:

ARTICLE !

The name of the corporation is Florida Women's Hockey League, Inc.

ARTICLE II

The term of this corporation is fixed in perpetuity and is to commence when these Articles of Incorporation are filed with the Department of State.

ARTICLE III

The Florida Women's Hockey League, Inc. is organized exclusively for recreational purposes, and in general, to exercise any, all and every power for which a non-profit organization organized under the Florida Not For Profit Corporation Act can be authorized to exercise. All of the property of this corporation and any accumulations thereof shall be held and administered to effectuate these purposes, in no event shall its property, whether principal or income, be diverted to private purposes.

Not withstanding any other provisions of these Articles, the Florida Women's Hockey League, Inc. will not carry on any other activities not permitted to be carried on by:

(A) A corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or

(B) A corporation, contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code of 1954, or any other corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the residual assets of the Florida Women's Hockey League, Inc. shall be turned over to an organization or organizations which themselves are exempt as organizations described in Sections 501(C)(3) and 170(C)(3) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or to the federal, state, or local government for exclusive public purpose.

ARTICLE IV

The initial registered office is located at 9175 150th Court, N, Jupiter, FL 33478, and Deborah

A. Danneman of such address is the initial registered agent.

ARTICLE Y

The number of directors constituting the initial board of directors is four (4), and such board shall be known as Trustees. The names and addresses of the initial board of Trustees are:

ARTICLE VIII

The power to adopt, alter, amend, or repeal bylaws shall be vested in the Board of Directors (Trustees). The Directors are elected by the Officers.

ARTICLE IX

The Articles of Incorporation shall be amended by resolution as provided in the bylaws, and the amendment incorporated therein when the amendment has been filed with the Department of State, approved by it, and all filing fees have been paid.
