ARTICLE I NAME, INCORPORATOR, PRINCIPAL OFFICE, REGISTERED OFFICE AND REGISTERED AGENT 4PR-5 P 3 H

Section 1.1 Name. The name of the Corporation (the "Corporation") shall be:

# ARTICLE II PURPOSES AND POWERS

Section 2.1 Purposes. The purposes for which the Corporation is organized are exclusively charitable within the meaning of the Florida Not-For-Profit Corporation Act, F.S.A. § 617.0301 et seq., and are:

- (a) To promote the Bartram Trail High School ACP Program at Bartram Trail High School located in St. Johns County, Florida through any and all legal means; and
- (b) To engage in any or all lawful business purposes or enterprises not for pecuniary profit for which corporations may be organized under the Florida Not-For-Profit Corporation Act and which the Board of Directors may deem to be in the best interests of the Corporation, and to do all other things deemed by the Board of Directors to be necessary or desirable in connection with any of the Corporation's business.

#### Section 2.2 Powers.

- (a) The Corporation shall have all the powers conferred upon a corporation under the provisions of the Florida Not-For-Profit Corporation Act, F.S.A. § 617.0302 et seq., and any enlargement of such powers conferred by subsequent legislative acts, and shall have all powers necessary, proper, convenient, or desirable in order to fulfill and further the purposes of the Corporation.
- (b) The Corporation is formed upon the articles, conditions and provisions herein contained and is subject in all particulars to the limitations relative to corporations contained in the general law of this State.

# ARTICLE III NO MEMBERSHIP CERTIFICATES

The Corporation is a not-for-profit corporation under the general laws of the State of Florida. The Corporation shall not issue membership certificates.

## ARTICLE IV TERM

The term of the Corporation is perpetual.

## ARTICLE V BOARD OF DIRECTORS

Section 5.1 Number. The powers of the Corporation shall be vested in the Board of Directors. The number of directors may be increased or decreased pursuant to the Bylaws of the Corporation, but shall never be less than one (1). The directors and their successors shall be elected or appointed pursuant to such procedures as are specified in the Bylaws.

<u>Section 5.2</u> Indemnification. The Corporation shall indemnify past or present directors and officers of the Corporation in accordance with and to the fullest extent permitted by the Florida Not-For-Profit Corporation Act, as amended from time to time.

These Articles of Incorporation were duly adopted by the Incorporator of the Corporation on February 2.4, 2004.
