ARTICLES OF INCORPORATION

in Compliance with Chapter 617, F.S. (Not for Profit)

We, the undersigned, desiring to become incorporated under the provisions of the laws of the state of Florida, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be Harvest Ministries Family Worship Center Inc

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The purposes for which the corporation is organized are: to operate exclusively for religious, charitable, educational and distinct ecclesiastical purposes within the meaning of Section 501 (c) 3 of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law thereto, and such purposes shall include the following:

- (a) Religious
- (b) To conduct a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the commandments and provisions as set forth in the Holy Bible, the irrevocable word of God. Pursuant thereto, the following activities and guidelines shall be established:
 - A recognized Creed, Code of Doctrine, discipline and form of worship shall be i. established
 - ii. An ecclesiastical form of government shall be established
 - Ordination of ministers upon completion of the prescribe course of study, designated iii. by this church ministry
 - An organization of ministers shall be established to minister to the congregation of iv. Harvest Ministries Family Worship Center Inc.
 - Establishment of a congregation membership based upon acceptance of a recognized ٧. creed and belief and support of the church
 - Spread the Word of the Gospel through seminars, radio, television, establishment of vi. church literature, and other forms of mass media for the purpose of educating the individual in the word of God
 - Establishment of various religious services pursuant to the recognized Creed, form of vii. worship, code of doctrine and discipline of the church and the establishment of Sunday Schools and religious Schools for Christians and educational instruction to the young and to the old.
 - Establishing a Bible Training School or School of Theology (not considered an viii. accredited educational institution) for the preparation of ministers who minister to Harvest Ministries Family Worship Center Inc
- (c) Minister the Word of God to the Faithful, and all others
- (d) Promote and encourage, through the ministry of the organization, cooperation with other organizations ministering within the community
- (e) To acquire and hold such property, either real or personal, for church purposes, as may be necessary for its membership and the worship of God

Article IV

In accordance with and in addition to the powers conferred by the laws of the State of Florida, the Non-profit Corporation shall have the following powers:

- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work
- (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit
- (c) To acquire, own, lease, mortgage and dispose of property, both real and personal
- (d) To conduct and carry on religious services and instruction through the public media, including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission, and cable television
- (e) To acquire, own and operate such broadcasting and/or telecasting facilities
- (f) To accept property and donations in trust for religious or charitable purposes
- (g) To acquire, hold, own, sell, assign, transfer, mortgage, pledge, or otherwise dispose of shares of the capital stock, bonds, obligations or other securities of other corporations, domestic or foreign, as investments or otherwise, in carrying out any of the purposes of the corporation and, while the owner thereof, to exercise all rights, powers and privileges of ownership, including the power to vote thereon

Article V

Harvest Ministries Family Worship Center Inc is not organized for the pecuniary gain or profit, nor shall it have any power to issue certificates of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any members, directors, trustees or individuals, except that Harvest Ministries Family Worship Center Inc shall be authorized to empowered to pay and to be paid a reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of activities of Harvest Ministries Family Worship Center Inc shall be the carrying on of propaganda or otherwise attempting to influence legislation, and Harvest Ministries Family Worship Center Inc shall not participate in or intervene in (publishing or distribution of statements) a political campaign.

Notwithstanding any other provisions of the Articles, Harvest Ministries Family Worship Center Inc shall not carry on any other activities not permitted to be carried on by:

- (a) A corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law or,
- (b) A corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.
- (c) In the event of dissolution of this corporation all of the business, property and assets of the corporation shall be sold and all debts of Harvest Ministries Family Worship Center Inc shall be paid; the remaining assets should be distributed to any religious organization that is backed by the Almighty God in which the Board of Trustees, Board of Elders and the General Overseer shall name at that particular time.

ARTICLE VI

The manner in which the directors or trustees of the corporation shall be elected or appointed shall be governed by the provisions of the By-laws of the Corporation. The ecclesiastical government of the church shall be conducted in accordance with the By-laws of Harvest Ministries Family Worship Center. The council of this church, as defined under the By-laws, shall constitute the board of trustees and shall have all powers over the temporalities of this church as the By-laws and relevant state law may prescribe. The pastor(s), if there be one or more, and any persons elected to the office of elder or deacon according to the By-laws must be members of the church. The corporate functions related to an office shall cease on the vacating of the office, but a vacancy in the office of the pastor(s) shall in no way affect the board of trustees. The corporation shall be a sovereign body, and the regulation of internal affairs of the corporation shall be governed by the provision of the By-laws of the Corporation.

ARTICLE VII

The Board of Trustees (Directors) shall be three or more in number, their names and addresses being as follows:
