A Florida Nonprofit Incorporation**

The Undersigned, majorities of whom are citizens of the United States, desiring to form a Non-Profit Public Benefit Corporation under the Non-Profit Corporation Public Benefit Law of the State of Florida, do hereby certify:

**ARTICLE I - Name of Corporation CHRISTIAN MULTI-CULTURAL ECONOMIC DEVELOPMENT ALLIANCE, INC. (C.M.E.D.A.)**

The name of the Corporation shall be as follows: **CHRISTIAN MULTI-CULTURAL ECONOMIC DEVELOPMENT ALLIANCE, INC. (C.M.E.D.A.)**

## **The Organizations' Purpose**

**MISSION:** The Christian Multi-cultural Economic Development Alliance, Inc., herein after referred to as "(C.M.E.D.A.) or "THE ALLIANCE" is dedicated to economically empowering and developing culturally diverse communities with an emphasis on the African American base by working with Faith-Based Organizations, Churches, Government entities, and committed Christians to provide sound stewardship training, seek access to capital, and endeavor to improve the quality of life for all citizenry.

**BACKGROUND:** Urban and Rural Communities inhabited by African Americans along the Gulf Coast Region suffer from the blight of poverty and neglect. Economic development programs intended for the individuals of the community are very limited. Unemployment is higher than that of the mainstream population; those employed suffer due to being paid lower than average wages. Training for meaningful jobs is almost non-existent, schools are inferior, and amenities commonly found in mainstream communities are not available. Improvements in these areas require Spiritual Involvement. We believe that the force of change can only be brought to bear by Christian Churches and Ministries.

**GOAL:** That all members of this community and the gulf coast region can spiritually state in earnest that: "The Lord is "Our" Shepherd, 'We' shall not want, He maketh "us" to lie down in green pasture, He leadeth "us" beside the still waters, He restoreth "our" soul, he leadeth "us" in the path of righteous for His name sake. Yea, tho "we" walk through the valley of the shadow of death, "we" will fear no evil, for God is with "us". Thou rod and Thy staff they comfort "us". Thou preparest a table before "us" in the presence of "our" enemies. "Our cup runneth over. We want every member to have the faith: "That surely goodness and mercy will follow "us" all the days of our life and "we" will dwell in the house of the Lord forever. C.M.E.D.A. endeavors to bring this peace to the community as a whole.

**ROLE/PLACE:** The Alliance and each individual have a specific place and role to play in the organization as a whole. God has blessed us each with a special gift that can be used to glorify His Kingdom and glorify His Name. We must avoid schisms, brought on by inflated egos.

Schism: a separation or division within a business, church, etc.... Any such separation within groups.

For as a body is one, and hath many members, and all the members of that one body, being many, are one body, so also is Christ. (I Corinthians 12:12) There should be no schism in the body! The members should have the same care, one for another. In addition, whether one member suffers, all the members suffer with it; or one member is honored, all the members rejoice with it.

**COMMITMENT:** One of the most lacking qualities in our day is commitment! Writers have written of this deficiency from numerous perspectives. They note that commitment is missing in various areas of society such as church, education, politics, business, media, at risk youth, and the family.

Commitment to family life set the stage for morality in our business and community. Couples who live together without the sanctity of marriage are not willing to make a commitment to each other. At the same time, many married couples end up in divorce because they failed to keep their commitment to each other. Whenever problems arise within the marriage, as they do in all marriages, the committed companions willingly work toward resolving them. Perhaps the heart of responsibility is committing ourselves to those who have entrusted or committed themselves to us. In the Old Testament, Joseph was an excellent example of true commitment and responsibility.

“.....However, he refused, and said unto his master’s wife, see here, with me in the house my master has concern about nothing he has put all that he has in my care. He is not greater in this house than I am nor has he kept anything from me except you, for you are his wife. How then can I do this great evil and sin against God? She spoke to Joseph day after day, but he did not listen to her, to lie with her, or to be with her.” (Genesis 39:8-10).

Because certain responsibilities were committed into Joseph's trust, he felt compelled to commit himself to his master. His tremendous level of commitment rebounded repeatedly to his receiving more responsibility from his supervisors. Because Joseph lived a life of commitment to right principles and responsibilities, he was eventually released from prison to assume the responsibility as governor of Egypt.

The Apostle Paul charged Timothy to keep or commit himself to that which had been committed to him. Commitment is a virtue that will return to the person who gives it. If we will commit ourselves to the purpose and cause of Jesus Christ, He will commit Himself to us in the Day of Judgement.

“...For the which cause I also suffer these things: nevertheless I am not ashamed: for I know whom I have believed, and am persuaded that he is able to keep that which I have committed unto him against that day”. (2 Timothy 1:12)

## **Land and Building Acquisitions**

Land and Building Acquisitions to be include, but is not limited to low-cost Affordable Housing for the Low Income to Low to Moderate Income Individuals for Affordable Housing, Land, Building and Structures for the varies Programs if the need for such acquisitions are required, for the implementation of these Programs by this Corporation.

- A. To expand opportunities available to said residents and groups to obtain adequate, low-cost housing accommodations by constructing, rehabilitating, and providing decent, safe and sanitary housing and/or facilities for persons and families of very low income, low-income to moderate income who otherwise would not be able to find or afford a suitable place to live. It is the purpose of the Corporation thereby to relieve the poor, distressed, underprivileged and indigent by enabling them to secure the basic human needs of decent shelter and to this lessen the burden of government and promote the social welfare. To provide such housing through land acquisition, production of affordable housing, rehabilitation of existing substandard building and construction of new facilities in the place of blighted structures or blighted vacant sites for the purpose of combating the deterioration of the community and contributing to it's physical improvement and other programs to aid those in need including for such purposes, the making of distribution to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All members and associates of the Christian Multi-cultural Economic Development Alliance, Inc., would be required to serve on a committee or in a department for the varies programs eliminating under this Alliance to assist the needs of the community as a whole including the varies programs for such purposes, the making of distribution to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV - Duration of Corporation**

The term of existence of this Corporation is perpetual.

#### **ARTICLE V – Classes of Members**

**MEMBERSHIP:** CMEDA will be members in the Christian Community Development Association, and support the Southern Christian Leadership Conference, the Urban League, National Association for the Advancement of Colored People, National Black Chamber of Commerce and National Center Reinvestment Coalition.

**ARTICLE X - No Benefit to Private Persons or Political Activity**

No part of the net earnings of the Corporation shall inure to the benefit of, or be attributable to its members, trustees, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. "Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree engage in an activities or exercise any powers that are not in furtherance of the purposes of the Corporation or by a Corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code."

**ARTICLE XI – Internal Affairs**

The Internal Affairs of the Corporation shall be governed in accordance with the By-laws of this Corporation.

**ARTICLE XII – Dissolution of Corporation**

Upon the dissolution of the Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the

designated successor exclusively for the purposes of the Corporation in which it was organized, or to such organization or organizations organized and operated exclusively for Charitable, Educational, or Religious purposes as shall qualify as an exempt Corporation under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
