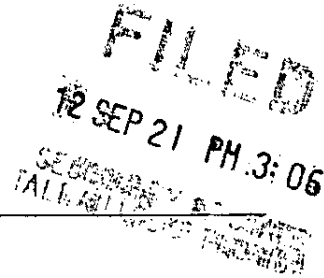

Upon the winding up and dissolution of this Corporation, after paying and adequately providing for debts and liabilities for this Corporation, the assets of this Corporation shall be distributed to Christian Church (Disciples of Christ) in Florida Inc., as long as this corporation remains a member of the Christian Church (Disciples of Christ) denomination. Christian Church (Disciples of Christ) in Florida inc. is organized and operated exclusively for religious purposes, and is exempt from taxation under section 501 (c) (3) of the Internal Revenue Code.
