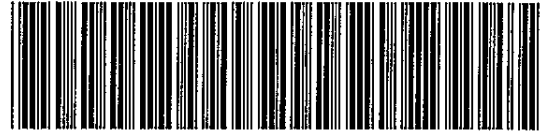

**ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not For Profit)

**ARTICLE I NAME**

The name of the corporation shall be:

HighTower Ministries, Inc.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: The City of Jacksonville, the state of Florida and the county of Duval.

**ARTICLE III PURPOSE**

Said Corporation is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes making of distribution to organizations that qualify as exempt organizations under section 501(c) 3 of the internal revenue code, or the corresponding section of any future federal tax code. The Purpose for which this corporation is organized is to

1. Minister the Word of God.
2. Conduct religious worship services and various forms of ministries;
3. Promote and encourage, through the ministries of the organization, cooperation with other organizations ministering the gospel of Jesus Christ;
4. Spreading the Word of the Gospel by ministering to all through seminars, radio, television, and other forms of mass media;
5. Conduct a local and international ministry by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all the provisions as set forth in the Holy Bible;
6. Provide religious educational opportunities of the religious and educational instruction of the young, as well as adults under the direction of the ministry.

Appointed by the President and Founder: Rev. Daniel Clark.

#### **ARTICLE V NET EARNINGS**

No part of the Net earnings of the corporations shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article third hereof. No substantial part of the activities of the corporations shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried (a) by a corporation exempt from federal income tax under sections 501(c) 3 of the internal revenue code, or the corresponding section of future federal tax code, or (b) by a corporation, contribution to which are deductible under section 170(c)(2) of the internal revenue code, or the corresponding section of any future federal tax code.

#### **ARTICLE VI Dissolution of Corporation**

Upon the dissolution of corporation, assets shall be distributed fir one or more exempt purposes within the meaning of section 501(c)(3) of the internal revenue code, or the corresponding section of a future federal tax code, or shall be distributed to the federal government, or the corresponding section of an future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets, not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporations is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
