Articles of Incorporation of South Florida Youth ASA, Inc. A Florida Corporation Non Profit

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

Article I Name

The name of the corporation shall be South Florida Youth ASA, Inc. (the "Corporation").

<u>Article II</u> Principle Office

The street address of the initial principal office of the Corporation shall be the following:

5201 S.W. 101st Terrace Cooper City, Florida 33328-4949

Article III Purpose

The purposes for which the Corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In addition, the Corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes

of this Corporation.

<u>Article IV</u> Corporation Subordinate to National Association

The Corporation will conduct its business subordinate to *The Amateur Softball Association of America* (hereinafter referred to as the *Association* or *ASA*, which is also doing business as *USA Softball* and *American Softball Association*), and in accordance with the code and regulations of *The Amateur Softball Association of America*.

In addition, the business of the Corporation shall be: 1) to promote amateur softball for all youth regardless of race, color, creed, religion, sex, national origin or ancestry; 2) to provide all youth and team managers with proper safeguards in accordance with the spirit of true sportsmanship and establish principles for ethical behavior and matters relating to conflict of interest; 3) to promote and conduct, when feasible, youth amateur softball championships; and 4) to educate and train all youth and team managers in the proper skills of amateur softball play and rules of the game through promoting, organizing, and conducting clinics, seminars and training courses.

Article V Initial Directors

The succeeding officers and directors of the Corporation shall be elected in accordance with terms and conditions set forth in the bylaws for the Corporation.

Article VI Non-Profit

The Corporation shall have all of the powers conferred upon corporations organized pursuant to the provisions of Chapter 617, Florida Statutes, as amended and supplemented.

Notwithstanding any provisions contained in these articles, the Corporation is required to distribute its income for each taxable year at the times and in the manner as not to subject the Corporation to tax under section 4942 of the Internal Revenue Code. In addition, the Corporation shall not, during any period and to the extent it is a private foundation described in section 509 of the Internal Revenue Code, (a) engage in any act of self-dealing; (b) retain any excess business holdings; (c) make any investments in a manner as to subject the Corporation to tax under section 4944 of the Internal Revenue Code; or (d) make any taxable expenditure as described in section 4945(d) of the Internal Revenue Code.

Article VII
Duration

The Corporation shall be perpetual.

Article VIII
Dissolution

Upon the dissolution of the Corporation, assets shall distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state of local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
