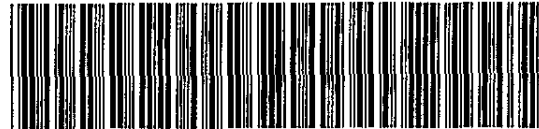

ARTICLE OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, desiring to form a corporation under the laws of the State of Florida, do hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized pursuant the Dade County Nonprofit Corporation Code.

ARTICLE I.

Purpose:

The general purposes and objects of this corporation shall be to conduct for religious worship and instruction, churches, and other institutions connected therewith of a religious, educational, and charitable character to the end and that its own members and others may be generally instructed and guided concerning its articles of faith; and to advance spiritual growth and enlightenment toward their personal purity among its own members and others may be

The number of Directors may be increased or diminished by majority vote of the existing Board, and it may hold annual elections. No power of the local church shall supercede that of the Executive Board of the Mother Church. This corporation shall have perpetual existence as a nonprofit mutual benefit corporation.


#### Article IX. Powers

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.


