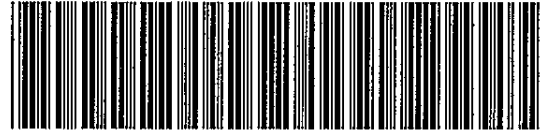

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be Olde Hyde Park Buccaneers Booster Club, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

Olde Hyde Park Buccaneers Booster Club, Inc. is organized exclusively for charitable, educational, literary, and scientific purposes, including, for such purposes, receiving contributions and paying them over to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code and are exempt from taxation under section 501(a), or the corresponding section of any future federal tax code.

Further, in the event of the dissolution of Olde Hyde Park Buccaneers Booster Club, Inc., the assets of the organization shall be distributed for an exempt purpose as described in section 501(c)(3) of the Internal Revenue Code, or to the federal government or State of Florida for a public purpose.

ARTICLE II MANNER OF ELECTION

Officers and directors of Olde Hyde Park Buccaneers Booster Club, Inc. shall be elected by a simple majority of ballots cast by members in good standing at the time of the election, which will be held annually prior to the beginning of each new fiscal year, at a time and place to be set by the then existing board of directors.


