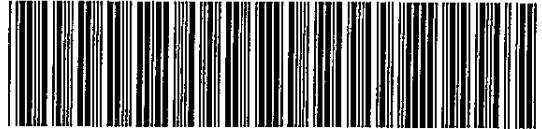

ARTICLE 1

The name of the incorporation is Bride Unveiled Ministries, Inc.

ARTICLE 2

ARTICLE 3

The purpose for which the incorporation is organized are set forth as follows:

The Incorporation is organized for such charitable, religious, educational and artistic purposes as may qualify it for exemption from the Federal income tax under Section 501 ©(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States internal revenue law.) More specifically, such purposes include, but are not limited to, the advancement of religious education, and artistic endeavor through discipleship training and further study of the scriptures of the Holy Bible, and development of artistic and creative abilities. Further purposes include ministering to those for salvation, healing and deliverance.
